### Schools & CSA Prevention/Intervention

Recently, someone posted a link on SpeakingOut's Facebook page that caught my eye. The article is called "The Role of Schools in Sexual Abuse Prevention and Intervention. ERIC Digest Series Number 61" and can be found at http://www.ericdigests.org/pre-9219/sexual.htm. Although an old article, I found some of the information quite helpful and should be read by all Teachers and School Personnel. For example... "The school is the one social institution outside the family with which nearly all children have consistent, ongoing contact. Therefore, it is particularly well-suited for identifying endangered children, including those who are being sexually maltreated."

There is a section in the article called "What Are Some Potential Indicators of Child Sexual Abuse?". It reads "Specific signs that MAY indicate sexual abuse include regressive behaviors such as thumbsucking, enuresis (bed wetting), and nightmares; sleep disturbances; persistent, inappropriate sexual play with self, peers, or toys; knowledge of sexual behavior (often evident in drawings) that is advanced for the child's age; poor peer relationships; overly compliant behavior; acting-out behavior such as delinquency or aggression



(often seen in children who attempted to get help but received none); pseudo-mature behavior; school-related difficulties including an inability to concentrate, faltering school performance, reluctance to change clothes for gym class or to participate in physical activities, and arriving at school early or staying late; running away from home; suicidal thoughts or attempts; and sexual promiscuity or avoidance of relationships (Deborah Tharinger and Ellen Vevier 1987)." Attention Teachers / School Personnel, unfortunately we live in a society where it is imperative for the safety of children (Kindergarten - 12th Grade) that each one of us is trained on the crime of child sexual abuse, to include what to look for. ### "Effective Victim Interviewing" (Recent Webinar)

On August 9th, Samantha Stewart of SpeakingOut attended a Free Webinar on "Effective Victim Interviewing" by EVAWI (End Violence Against Women International). Joanne Archambault is the Executive Director of EVAWI at www.evawintl.org. Read what Samantha has to say after attending the webinar...



"I had the pleasure of attending the "Effective Victim Interviewing" training webinar by EVAWI. They had an immense amount of information helpful to the individuals who work in law enforcement and the court systems to assist victims of assault through their traumatic experiences. They acknowledge numerous procedures and techniques that can be revised and improved to better aid with the processes that an individual experiences when disclosing their trauma.

What I found to be very interesting is how individuals who experience trauma are susceptible to a temporary amnesia. Because of this temporary amnesia, it is important that both the interviewing officer and the victim take in considerations for their timelines, memory, and effects it might have on the process.

Joanne Archambault discussed these timelines and how the officer(s) and victim(s) should approach the interview to gather the most preeminent information with the least distressing impact on the victim as possible. Before the first sleep period, a person will only be able to recall general characteristics. After

the first sleep period, the individual's ability to remember the event(s) will increase from 50%-90%. An individual's ability to completely remember will not occur until after the second sleep period.

Adult and young adult survivors often contact SpeakingOut with their stories and experiences. We attended this webinar to acquire any information that would be helpful in assisting us to continuously support those survivors across the U.S., and learn new information for those yet to come forward. Overall, this training included constructive tools in which we can utilize within SpeakingOut in the fight to prevent, protect, and support victims of abuse."

# SpeakingOut & LaunchPoint (Knoxville, TN)

### LaunchPoint

(A Program of Knox Area Rescue Ministries)

"LaunchPoint is a four-week program designed to help homeless men and women begin a new life journey. Ultimately, LaunchPoint is about restoring hope - reconnecting the individual to the dreams that he or she once had but were lost when the individual's life path went off track. During the four-week period, a class of 20 participants begin discovering God's plan and purpose for their lives, develop their own life plan with realistic goals, and learn to implement their life plan in manageable steps." In June, SpeakingOut was contacted by Clark Stevens, Ph.D., the LaunchPoint Director at KARM. He informed me of this new program. We set up a meeting to discuss how SpeakingOut may be of assistance to the participants of the LaunchPoint program. Mr. Stevens also informed me that of the men and women who had come through the program to date, more than half had reported histories of trauma with childhood sexual abuse as the primary trauma. Mr. Stevens and I both agreed that it may be helpful for participants to know that there are people out there fighting against this crime; on their behalf. Because many of these now adults were probably never helped or even believed if they disclosed, we decided it might help to share with them what SpeakingOut is out there encouraging every day...that it is the adult's responsibility to be aware of this crime against innocent children, that it is the adult's responsibility to do all we can to help prevent this from happening to children, that it is the adult's responsibility to know the signs & symptoms to look for, etc... Mr. Stevens & I then discussed the message we wanted SpeakingOut to try to convey... What a "protective parent" would do in caring for a child, and what a "protective parent" would do in caring for the child within themselves. Basically, the thought process was that by learning a new way to protect children from sexual predators, maybe these individuals would learn how to better care for themselves in situations that are potentially dangerous.

On August 9th, SpeakingOut presented to the LaunchPoint group. The participants were very interactive, as well as open about their feelings toward the crime of child sexual abuse. We discussed why children don't tell; some of the contributing factors in what may cause someone to violate a child; the importance of parents opening up the communication line between them & their child/children; how crucial it is for any adult, especially a Parent, to believe their child if/ when they disclose what someone may be doing to them; etc... The time spent with this wonderful group of kind and caring individuals went by very quickly.

SpeakingOut on behalf of all children who have ever been (child & adult survivors), are being or will be sexually abused. "Thank you, Susan, for your kind and compassionate approach to addressing childhood trauma. Your honest, straight forward approach allowed many participants in our program to break their bondage to secrecy as they revealed painful life experiences with each other. At the end of our four week program, many individuals stated your conversation with them made a lasting impact on their lives. # SpeakingOut & Serenity Shelter (Knoxville, TN)

### **Serenity Shelter**

(A Program of Knox Area Rescue Ministries)

"Serenity Shelter for women provides Biblically-based recovery services, case management, individual and group counseling, spiritual support, crisis intervention, life skills classes, community-based mentoring, and refuge from abusive relationships for women who are seeking help." At the end of June, SpeakingOut met with the Serenity Shelter Program Director, Barbara Davis. We brainstormed on how we felt SpeakingOut may be able to best assist the women who participate in this Residential Recovery Program. What I learned is that Serenity Shelter is a biblically-based, long-term recovery program for women facing various life situations, many who have suffered various types of abuse throughout their lives with much of that being of a sexual nature. I also learned that many of these ladies are Mothers & several are Grandmothers.

Barbara and I wanted to look at the idea of starting a new class at Serenity Shelter where SpeakingOut would meet with these ladies weekly; on an ongoing basis. So on **August 10th**, I sat down with the group, told them who I am, told them about SpeakingOut and where it came from, and gave them a brief overview on what SpeakingOut does. When asked if they felt they may benefit from starting a new class, I was welcomed with open arms. That day, as a group we decided to call our new class "SpeakingOut".

We've held 4 classes so far and have discussed the following...

- Week 1: My Personal Experiences with the Crime of CSA / Overview on SpeakingOut & What We Do
- Week 2: Message to Survivors
- Week 3: Truth & Reality of Child Sexual Abuse / The Statistics
- Weeks 4: What Child Sexual Abuse Is
- Next Group Session: Signs & Symptoms of the Sexually Abused Child.

During each class to date, the ladies have been very interactive, sharing their experiences openly and asking questions in an effort to gain a better understanding on the crime of child sexual abuse. We are having very productive discussions on not only the crime itself, but on what each one of us can do to help prevent this crime from happening to other children.

"SpeakingOut against Child Sexual Abuse, Inc. has recently partnered with Knox Area Rescue Ministries' Serenity Shelter. Serenity Shelter is a program that provides restoration and recovery to women with various life struggles. SpeakingOut's President, Susan Suafoa-Dinino is providing a weekly group session with the ladies of Serenity to educate and inform regarding the facts and myths surrounding Child Sexual Abuse and to process some of the personal struggles faced by some of the women at Serenity surrounding sexual abuse. talking to people.




