Artism Day Spring Festival


Art Event for Children with Autism and other Disabilities

It's Bad Enough Children are Violated...


But Did You Know?

- A large % of Children who are being violated will remain silent about their abuse.
- For the Children who do disclose, many are not being believed by their loves ones & others.
- Only a small % of Child Sexual Abuse cases are ever reported.
- And the majority of reported cases will never see a courtroom.
- Far too many cases of Child Sexual Abuse wind up in Family Court; rather than Criminal Court. Child Sexual Abuse (Rape, Molestation, Incest & Exploitation) is NOT a family matter... It is a Crime!
- In far too many cases, the Reporting (Non-Offending) Parent is persecuted and in some cases prosecuted for speaking up and trying to protect their child.
- More often than anyone would like to believe, Children are being taken from the Reporting (Non-Offending) Parent and custody is being given to the Abusive Parent.
- Many, Many times, the Abuser is protected and the child continues to suffer. This leaves the Child in the position where they may be violated repeatedly; sometimes over the course of many years.
- It is estimated that 95% of Children who are sexually abused know the person abusing them, and in far too many cases, loves and trusts that person.
- The majority of those who violate innocent children tend to average multiple Child Victims.
- Justice May Never Come for the Child who has been sexually abused.
- First and Foremost, the most innocent of all Victims... Children... are Suffering!


