Innocence is NOT Lost...it's Stolen

I recently overheard a conversation in which someone said... "That's a shame. That poor, little boy lost his innocence." A child who had been sexually violated by someone the child knew was the subject of the conversation. Hearing it put that the boy "lost his innocence" really stopped me in my tracks. It was so clear and I was reminded that a child does NOT lose their innocence when they are sexually violated. It's not the same thing as a child losing a shoe or a toy. When a child is sexually violated in any form, their innocence is STOLEN from them... whether by an adult or even an older child. It takes a conscious effort on someone's part to rape, molest and/or exploit a child.

I was also reminded by hearing this conversation that how we say things when addressing the topic of Child Sexual Abuse makes a huge difference in how what happened to the child is perceived. We need to tell it like it is and not downplay or try to be politically correct about these matters. That will not help the multitudes of children being violated every day. We need to speak Truth & Reality by speaking bluntly to the severity of this crime committed against the most innocent of all victims... Children. What Child Sexual Abuse really is...

Rape / Incest / Molestation / Exploitation of Children

More Truth & Reality... Children of all ages (from Birth to 17 Years of Age) are being violated every single day in this country. Please understand that although it is impossible to fathom for most of us, even infants are being molested & raped. What could possibly be going through a person's mind in order for them to do such a thing to a baby, or a child of any age for that matter? How perverted!







Because SpeakingOut against Child Sexual Abuse, Inc. exists to be a voice for children, as well as a voice for adult survivors of childhood sexual abuse, there have been many times that I have been told by others that Child Molesters / Child Rapists are people too. I have also been told repeatedly that these same people have rights too. I find myself shutting down to those ideas... because all I can see is what they did to a child or children. The safety of children is SpeakingOut's # 1 priority.

I would like to clarify that when we say we are "SpeakingOut on behalf of all children who have ever been (child & adult survivors), are being or will be sexually abused", we mean that SpeakingOut represents those who are "Non-Offending Survivors of Childhood Sexual Abuse". We understand and agree that most who violate children were they themselves violated as a child. And no child should have to go that. However, like with everything else in life, each of us have choices to make. We can either break harmful cycles or we can harm others by repeating behavior that was taught to us. Everything in life is a choice. Once a person chooses to sexually violate a child, they become that person we are SpeakingOut against. In summary, we represent "Non-Offending" Adult Survivors.

Message to Adult Survivors

Don't be a Victim any longer... BE A SURVIVOR!

It was NOT YOUR FAULT...

Regardless of how old you were, regardless of how long it went on & regardless what your Abuser or anyone else has ever told you, it was not your fault. You were a CHILD! We believe a Child is a child from birth to 17 years of age. You were taken advantage of by someone in Authority over you.

And the only shame in that is that of your Abuser.

YOU MUST BELIEVE THIS WITH YOUR WHOLE HEART!

There was nothing that you did to cause your abuse. There was nothing wrong with you why you were picked out. It is as simple as this... Your Abuser either had access or gained access to you. The molesting & raping of children is their (the abuser's) issue; a choice they made. You did nothing wrong. So when you question why you, why you may not have told anyone or why you didn't or couldn't stop them, remember that you were just a Child.

YOU CAN DO MORE THAN JUST SURVIVE!

Reveal the Truth... Uncover the crime committed against you when you were a child. Don't keep it a secret any longer. There's no shame in it for you, regardless of how it may feel. Again, you were under the age of 18...a child... an innocent victim. But that doesn't mean that you have to remain a Victim for the rest of your life.

Talk About It... There is healing in being able to talk about the violation you endured as a child. Find that person or group that you feel safe with & trust to discuss your abuse openly. The purpose is to face what happened & move forward. Because of the sensitivity of this topic, if you fail to find that right person/group at first, try again. There are people out there that are willing to listen. **You are not alone.**

Seek Professional Help (If Needed/As Needed)... Counseling, Support Group, Therapy, etc... You can also do your own research to find the right avenue for you. For example, you may want to talk to your local Pastor about resources in your area.

Do Something About It... Get Involved in the fight against Child Sexual Abuse; whatever that means for you. Help break the cycle.

Truly Heal, Overcome, Conquer... The act of sex was created by God as a beautiful thing for a husband and wife. However, society (people) have misused sex & distorted it in just about every possible way. One of these ways is by Raping, Molesting & Exploiting Children. Sexual acts were never intended to be used as a weapon against anyone, especially innocent children.
